(ii) Your letter No. H2/35920/2011/DPI dtd 14.10.2011.

With reference to the points raised in your letter referred above, the following clarifications are issued.

a) Consequent on the issuance of the G.O.(P) No.199/11/G.Edn. dated, 1/10/11 the orders such as G.O(P) No.178/2002/G.Edn. dated 28/6/02, G.O (P) No.46/06/G.Edn. dated 1/2/06, G.O (MS) No.259/06/G.Edn. dated 12/10/06, G.O (P) No. 10/10/G.Edn. dated 12/1/10 etc. have relevance only up to 1/10/11.

However, G.O.(P) No.199/2011/G.Edn. specifically addresses the case of all appointments entangled with the issues covered in the various executive orders referred in your letter. It is clarified that in all such cases appointment approval can be given with effect from 1/6/2011 and prior service before the current academic year will be reckoned in line with the proposed amendment

to KER. In other words in all such cases appointment approval can be given in two stages. In the first stage, if the teacher is included in Appendix-I, they may be given approval with effect from 01/06/2011. Approval for the prior period may be given on a case to case basis in the 2<sup>nd</sup> stage after the KER amendment comes into effect

- b) In the case of promotions (43 claimants) it is clarified that they can be paid salary of the promoted posts from 1.6.2011 and substitutes appointed in their places, can be paid salary with effect from 1.6.2011 provided such substitutes were already in position before 31.3.2011. It is also clarified that 43 claimants can be paid salary at the rate of lower category till 1.6.2011. Payment of salaries to substitutes before 01/06/2011 and at higher scales to 43 claimants before 01/06/2011 will be considered on a case to case basis in line with the amendment to KER
- c) In all cases where bond has been executed the appointments of teachers in Appendix 1 can be approved with effect from 01/06/2011 for the time being. Prior period of approval will be considered on a case to case basis in line with the KER amendment.
- d) All appointments made against Leave vacancies exceeding eight months can be approved with effect from 01-06-2011 on regular scale provided such appointments have been effected before 1/10/2011, i.e the date of G.O(P) No. 199/2011/G.Edn. However, if appointments are made against any leave vacancies after 1/10/2011, the same can be approved on daily wages basis till the teachers bank is formally constituted and leave substitutes are made available from the bank.

e) Additional division can be sanctioned based on the Higher Level verification

conducted during 2010-2011.

f) To consider this matter, Government would require a list of such schools

and the number of vacancies. It is clarified that fresh appointments in such

cases will not be allowed.

Several cases have come to the notice of Government that Government and

Aided schools have not been reporting the actual students strength for 2011-12 and

have just reported the effective strength/figures arrived at during the one-day

verification process. This is a serious issue. DPI may direct all educational officers

to ensure that only the actual students strength is being reported, random checks

may be conducted in selected schools, particularly all schools which were affected

by Supercheck Cell visits in the last five years and also such schools where

substantial excess text books have been reported during the current year. In case

of discrepancies disciplinary action may be taken against the Headmasters

concerned and show cause notice for disqualification of aided managers may be

served.
