ORDER

As per Government Order read as 2nd paper above, 13 persons have been appointed as District Educational Officer (Trainee) by direct recruitment through KPSC in which 4 persons are selected as departmental quota candidate (Teaching staff) and the remaining persons as open quota candidate. As per Government Order read as 1st paper above, a person recruited direct from open quota should undergo training for a period of 1 ½ years and persons recruited from the departmental quota (Teaching staff) should undergo training for a period of 1 year.

The Director of Public Instruction has informed that the District Educational Officer (Trainee) who were recruited under departmental quota (Teaching staff) have successfully completed their training on 22.11.2011 and forwarded the proposal for the posting of those 4 officers, as per letter read above.


