S. R. O. No. 453/2012.—In exercise of the powers conferred by section 36 of the Kerala Education Act, 1958 (6 of 1959), the Government of Kerala hereby make the following rules further to amend the Kerala Education Rules, 1959, namely:—

RULES

1. Short title and commencement.—(i) These rules may be called the Kerala Education (Amendment) Rules, 2012.

(ii) They shall come into force at once.

2. Amendment of the Rules.—In the Kerala Education Rules, 1959, in Chapter VI, in rule 3, to sub-rule (1) the following proviso shall be added, namely:—

"Provided that the authority notified by the Government shall not alter such details entered in the Admission Register without the support of a Certificate from the Competent Revenue Authority concerned or the Registrar of Birth and Death concerned, as the case may be".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-rule (1) of rule 3 of Chapter VI of Kerala Education Rules 1959, as amended by the Kerala Education (Amendment) Rules, 2011, published as S.R.O. No. 101/2012, the name of a pupil, his religion, his caste and his date of birth once entered in the Admission Register shall not be altered except with the sanction of the authority specified by Government in this behalf by notification in the Gazette. The Government, while taking a decision to specify the Headmasters of the school as an authority under this rule, have also decided to make provision to insist that such alternation of the details entered in the Admission Register shall be done only with the support of the Certificate from Revenue Authorities or the Registrar of Birth and Death, as the case may be. Hence it necessitates amendment to rule 3 (1) of Chapter IV of the Kerala Education Rules, 1959.

This notification is intended to achieve the above object.
