ORDER

As a part of Government decision to upgrade U.P. Schools as High Schools in those Grama Panchayaths which do not have a High School, Government vide G.O. read as first paper above ordered to upgrade three U.P. Schools, including Govt. U.P. School, Chullikkode in Muthuvallur Grama Panchayat in Malappuram District. Government vide order read as second paper above cancelled the upgradation of Government U.P. School, Chullikode, Malappuram District. Division Bench of the Hon'ble High Court in Orders dated 04.06.2008 and 11.07.2008 in WP(C) No. 16660/2008 stayed Government decision to cancel the upgradation of Govt. U.P. School, Chullikode. In the light of the said order of the Hon'ble High Court, the High School section in Govt. U.P. School, continued to function.

- Considering the request of the P.T.A. of the school and the local people, Government re-examined the matter and ordered to nullify the portion of G.O.(Ms) No. 98/2008/G.Edn. dated 31.05.2008, regarding the cancellation of upgradation of Chullikkode Govt. U.P. School and ordered to upgrade the school as High School in partial modification of said order vide Government order read as 3rd paper above.
- 3. Though upgraded as High School, necessary posts were not sanctioned to the high school section of Govt. UP school Chullikode. The Deputy Director of Education, Malappuram has forwarded a proposal for creation of one post of Head Master, 4 posts of HSA (core), one post each of HSA (Arabic), HSA (Hindi), HSA (Malayalam part time), LDC, Peon and FTM for the High School section of the School vide letter read as 4th paper above.

4. Government have examined the proposal in detail and are pleased to sanction the following posts to the High School section of the upgraded Govt. U.P. School, Chullikode, Malappuram District.
