General Education - Implementation of Right to Education Act-Appointment of Independent Head Teachers in Lower Primary and Upper Primary schools and Exemption from class charges-sanction accorded-orders issued.

ORDER

As per the Right to Education Act, the Schedule of norms and standards for a school stipulates to have an independent Head teacher in all Lower Primary schools having more than 150 children and a full time Head teacher for all Upper Primary schools having above 100 children. The State Project Director, Sarva Siksha Abhiyan has reported that, the Ministry of Human Resource Development, Government of India in the Project Approval Board 2011-12 has approved the appointment of 1322 independent Head Teachers to LP schools having enrollment over 150 and the appointment of 1355 independent Head Teachers to UP schools having enrollment more than 100 at the rate of Rs.25000/- per men sum towards their salary components. The State Project Director has therefore requested to accord sanction for appointing 1322 teachers in LP schools and 1355 teachers in UP schools.

In the circumstances, Government are pleased to accord sanction to dispense with the present system of holding class charges by 1322 Head Masters in LP schools having more than 150 students and 1355 Head Masters in UP schools having more than 100 students. Sanction is also accorded for the creation of posts of LPSA's & UPSAs on temporary basis wherever necessary consequent to the said exemption of class charges of Head teachers (Head Masters). Such posts shall be filled up on daily wage basis during the current academic year. The Director of Public Instruction will furnish the details of schools and posts to Government in due course.

The Director of Public Instruction will identify such schools, and quantify the salary commitment due to the above arrangements. He will claim the amount from Sarva Siksha Abhiyan and deposit to the Government head of account and disburse. The existing system of salary disbursement using SPARK and through the treasury will be continued.
