As per the order read as 3rd above the vacancies of UD Clerks in this Department upto 05/01/2010 were filled up by promoting qualified LD Clerks who had entered in service upto 14/12/1999. After that a few more requests/service cards have been received for claiming inclusion in the above said order. The service cards thus received from sub-offices and from individuals were examined with reference to the seniority list of LD Clerks (1993-2000) and found that they are also eligible for promotion. In this circumstance it is found that this office order read as 3rd paper above needs a partial modification/review.

During 20/07/2007 to 31/07/2010 there are 404 UDC vacancies are considered to grant promotion including modification of the previous order dated 29/01/2010 from the qualified LD Clerks who were entered in service from 24/02/1997 to 17/09/2001. Out of this, 239 vacancies were utilized for the modification of the previous UDC promotion order (Rank No. from 408 to 753) order dated 29/01/2010.

The details regarding the number of vacancies utilized for promotion is given below:

As per this office order read as 3rd, 239 vacancies from 20/07/2007 were utilized for effecting promotion among the qualified LD Clerks who were entered in service from 01/01/1997 to 14/12/1999 in the seniority list of LD Clerks for 1993-2000 and omission cases now reported who were entered in service before 14/12/1999 including request for category change from UD Typists. Accordingly the order 3rd read above is hereby modified and the LD Clerks are provisionally promoted to the cadre of UD Clerks with effect from the date noted against their names in the appendix. There is no change in the above order so far as promotion of LD Clerks who have been promoted as UD Clerks on 29/01/2010.

There are 165 LD Clerks are newly promoted as UD Clerks from the LDC Seniority list of 1993-2000 (Rank No. from 754 to 888) and the LDC Seniority list of 2001-05 rank upto 70 included for promotion. The list of promotees is given in the appendix. If any one is aggrieved with the provisional promotions (UDC) now effected herein may file their objections/appeals within 30 days from the date of issue of this order.

The promotions now ordered are purely on provisional basis in terms of Rule 31 a(1) of KSSR and subject to further review, if found necessary on the basis of judgments issued in future in respect of various WP(C)s pending before the Hon'ble High Court of Kerala and other court of law. ***The Head of Offices/Controlling Officers will ensure that, the details furnished in respect of Department tests passed and date of effect of seniority reckoned in the Promotion Order in respect of the employees under their control are correct as per the***

entries made in their Service Book. If any one of the persons promoted is found to be not qualified for promotion, his/her promotion should not be effected and the fact should be reported to this office with relevant details. The persons who got inter-district transfer after the preparation of final seniority list and before the date of effect of promotion should also be exempted.

The persons who are promoted will be retained in the office in which they are now working. ***If any of the promotees is not working in the office/school shown against his/her name, a copy of this Order and extract of the Appendix should be forwarded to the office/school where the employee is presently working.*** Necessary entries regarding the promotion should be recorded in the Service Book of the incumbent after verifying the facts under proper attestation. ***The Deputy Directors/Controlling Officers concerned will issue necessary posting orders to the persons whose category is changed as UD Clerk according to the availability of vacancies.*** The Controlling officers will alone be responsible for any lapses as detailed above which found in future and action will be taken against them as per rules and executive orders.
