**ORDER No.C5/5/2013/DPI DATED.28/02/2013**

As per the order read above, the eligible LD Clerks entered service upto 17/9/2001 were promoted as UD Clerks in the vacancies which arose upto 31/07/2010. After that a few more requests/service cards have been received claiming UD promotion. The Service Card thus received from sub offices/controlling officers were examined with reference to the seniority list of LD Clerks and found that they are also eligible to be promoted against the vacancies which arose upto 01/04/2010.

In this circumstance, it is not practical to review all promotion orders issued earlier and so it is decided to allow them notional promotion as UD Clerks with effect from the date of promotion of their immediate eligible juniors who were already promoted as UD Clerks and ordered accordingly. The promotions now ordered are purely provisional in terms of Rule 31(a) (1) of KS&SSR subject to further review if found necessary. The Head of Offices/Controlling Officers will make sure that the details furnished in the promotion order in respect of the employees under their control are correct as per the entries furnished in their Service Book. If any one of the person promoted is found to be not qualified for promotion/Notional promotion, his/her promotion should not be effected, and the fact should be reported to this office with relevant details. *They are not eligible for any back arrears for the notional promotion granted to them.*

The persons who are promoted as per this order will be retained in the office in which they are now working. If any promotee is not working in the office/school shown against his/her name a copy of the order and extract or the appendix-1 should be forwarded to that office/school where the employees are presently working. Necessary entries regarding the promotion of the employees should be recorded in the Service Book under proper attestation.
