As per the order read as 1st paper above, the final seniority list of HM/AEO and equated categories for the period from 23/07/2008 to 12/01/2011 has been finalized and published. HSSTs were not included in the above list, since they were not promoted/relieved as HM/AEOs based on the direction contained in the Govt lr.no.12970/C2/2010/GAD dt.07/04/2010.But based on the judgment dt.14/03/2011 in WA No.2070/2010 Govt issued direction to include the HSSTs for promotion to the posts of HMs/AEOs as per Govt lr.no.38048/C2/2010/GAD dt.03/09/2010.As such 25 HSSTs were included in the select list approved by the DPC[L] held on 12/05/2011.

Sri.Brahmasuthan and Sri.A.K.Appukuttan filed WP[C]No.31262/2011 before the Hon. High Court to include their names in preference to their juniors in the seniority list. The Hon High Court in its judgment dt.23/11/2011 directed Govt: to take decision with notice to the affected parties. After considering all the aspects in the matter the issue has been placed before the DPC held on 27/03/2012. Since there was no dispute about the inclusion of their names in the select list, the committee decided to take up the matter with Government by the appropriate authority. Govt accorded sanction to promote the 25 HSSTs retrospectively as per GO[Rt] No.2539/2012/GAD dt.02/06/2012. As such as per order read in 4th paper the 25 HSSTs were notionally promoted.

In the above circumstances the rank of the above HSSTs were re-assigned and appended. The controlling officers are directed to circulate the list among all the concerned.
