No individual communication will be sent to the incumbents from the office. The controlling officer is directed to download the order and distribute the copies to the concerned persons accordingly. The Promotion of Headmaster is purely provisional. The provisional promotion of the HSA as HM now ordered is liable to be changed/cancelled if any discrepancy is found later by the undersigned.
