the Kerala Education Rules, 1959, namely:-Government of Kerala hereby make the following rules, further to amend section 36 of the Kerala Education Act, 1958 (6 of 1959), the S. R. O. No. 719/2018.—In express of the powers conferred by

the Kerala Education (Amendment) Fules, 2018. . Short title and commencement -(1) These Rules may be called

2. Amendment of the Rules.—In the Kerala Education Rules, 1959 in CFa for XXVI, in rule 1, the following note shall be inserted, namely:—

who has not completed the prescribed period of minimum continuous service specified in these rules shall be entitled and eligible to receive only the time bound higher grades of pay under the pay revision orders issued by the Government of Kerala in the first higher grade on completion of the required period of service specified in the said pay revision orders. A teacher promoted and posted as Headmaster under these rules shall be entitled and eligible to receive the first higher grade of pay revision orders. Explanatory Note

Rule 1 of Chapter XXVI of Kerala Education Rules, specifies that, 15 years of continuous service is required as a teacher in schools recognised by the department, for a seather promoted as Headmaster for bing sligible to receive the scale of pay applicable to Headmaster. It is also say affect therein that those Headmaster who have not put in this minimum service of 15 years shall be given their grade pay and supervision allowance as may fixed by Government until they complete the prescribed minimum service.
