As per this office circular read in 1st paper, applications were invited from qualified hands of the Head of Departmental High Schools or Assistant Educational Officer's and equated categories for the post of Chief Instructor in RILT Thiruvananthapuram on Rs.39500-83000 by transfer according to the Special Rules. But none of them have submitted application for the said post. In the Government Order read as 2nd paper, sanction was accorded to fill up the post of Chief Instructor from the qualified HSAs and equated categories in the absence of qualified persons as per Special Rules.

Smt.Bindu T.P, HSST (Jr), Hindi, GHSS Kattilapoovam, Thrissur is the senior most qualified applicant for the post of Chief Instructor, RILT, Thiruvananthapuram based on the applications received in response to the Circular.

In the circumstances stated above, Smt.Bindu T.P, HSST (Jr), Hindi GHSS Kattilapoovam is promoted on purely provisional basis to the cadre of Chief Instructor RILT, Thiruvananthapuram on Rs.39500-83000 under Rule 9(d) of KS&SSR 1958 and posted as Chief Instructor, RILT Thiruvananthapuram with immediate effect. The appointment is purely on provisional basis subject to the further conditions that she shall not by reason of this appointment, be regarded as a probationer in this service class or category nor she acquire there by any preferential right for further appointment to the next service class or category. She will however be entitled to the monetary benefits attached to the post. She will not

be regarded as a probationer in the above category till she is promoted on a regular basis as per general seniority of HSA to the cadre of HM/AEO on Rs.39500-83000.

The Head of the Institution will ensure that the promotee has passed test in Account Test (Lower) and KER conducted by the PSC (vide explanation under Rule 44 (a)of Chapter XIV (A) KER. If there is any doubt, the promotee need not be relieved and the fact should be reported to this office immediately for further Instructions.

The Head of the Institution will relieve the person under orders of promotion within 7 days with directions to report for duty at her new station under intimation to this officer.
