As per the Government Order read as 1st and 2nd paper above, 20% ratio promotion (Higher Grade) has been ordered in the cadre of Fair Copy Superintendent w.e.f. 01/02/2011 in time scale Rs.18740-500-21240-560-24040-620-27140-680-29800-750-32800-820-33680. The existing cadre strength of Fair Copy Superintendent in the department is 17. Based on the provisions contained in the Government Order 3 Fair Copy Superintendents are eligible for Fair Copy Superintendent (Higher Grade).
