As per Government Order read as 1st paper above the Government has sanctioned 25% Ratio Promotion to Junior Superintendents w.e.f. 01/02/2011. The cadre strength of Junior Superintendent and Store Keeper in the Department as on 01/02/2011 is 285. Accordingly, 71 Senior most Junior Superintendents are eligible for Higher Grade w.e.f. 01/02/2011.

As per Government Order read as 2nd paper above the Government has sanctioned 163 Noon meal Officer post in the cadre of Junior Superintendent in the Assistant Educational Offices. Hence the cadre strength of the Junior Superintendent in this department is enhanced to 448 w.e.f. 05/06/2015 from the 448 Junior Superintendents/Noon Meal Officers/Store Keepers (25%) 112 Senior most Junior Superintendents are eligible for Higher Grade.

As per Government Order read as 3rd paper above the Government has sanctioned 1/3rd of Ratio Promotion to Junjor Superintendents w.e.f. 01/04/2016. Therefore out of 448 Junior Superintendents in this Department 149 Senior most Superintendents are eligible for Higher Grade in the scale of pay of Rs.35700-75600/- w.e.f. 01/04/2016.

Now consequent on promotion of the senior most Junior Superintendents 2 senior most Junior Superintendents are found eligible to be granted ratio based Higher Grade promotion in the time scale Rs.35700-76500/-. Hence, ratio based Higher Grade is sanctioned to the following Junior Superintendents/Noon Meal Officers/Store Keepers w.e.f. the date shown against their names.

The incumbents who have not enjoyed the 4th Time Bound Higher Grade are eligible for fixation of pay under Rule 28A Part I KSR in terms of GO(P)No.7/2016/Fin dated, 29/01/2016.

The eligible incumbents should submit their fixation statement within one month from the date of this order before the Controlling Officer.
