FOOT NOTES

- 1. The lien of the deployed Junior Superintendents in Text Book office/District Text Book Depots may be maintained in the Text Book Office/DTBD itself. Their salary and allowances should be claimed and disbursed only through the TBO/DTBD until further order in this regard.
- 2. The deployed incumbents are directed to report for duty before the concerned controlling officers/DEOs. The controlling officers/DEOs are directed to admit them in the respective DTBDs and then relieve with direction to report for duty before the controlling officers concerned in which they are deployed on the very same date.
- 3. The Deputy Director of Education, Idukki should be issued suitable posting order to Sri. Jaimon (Store Keeper, DTBD Kattappana) as Senior Clerk within the Revenue District and take necessary steps to draw and disburse the present pay and allowances until further orders.
- 4. The Deputy Director of Education, Thrissur should be issued subsequent posting orders to the present Store Assistant/Store Keeper of DTBD Chavakkad/Irinjalakuda in their entry cadre (Office Attendant) within the district and draw and disburse the present pay and allowances until further orders.
- 5. All the DEOs are entrusted to the custodian of the Government properties in the DTBDs. The DEOs are directed to obtain a list of Government properties in the DTBDs from the present Store Keepers.
- 6. The DEOs are also directed to enlist and furnish a copy of the list of Government properties in the respective DTBDs along with the relieving order/joining duty report of the Store Keepers/Junior Superintendents.
