ORDER

The Director of Public Instruction as per his letter read above, has submitted proposal for Administrative sanction for the scheme 'Financial Assistance to Children with Special Needs in Standard I to VIII under Student Centric Activities' as detailed below. The proposal is to provide assistance in the form of book and stationery allowance, uniform allowance and transportation allowance to all Children with Special Needs (CWSN) in classes I to VIII, Escort allowance to CWSN students of orthopedically handicapped category with severe disability (60% and above), all children with mentally retarded(MR) Autism categories and Students with Visual Impairment (VI) having 75% or more disability and Readers allowance to visually impaired students of Standard VI, VII and VIII.

- 3.Government have examined the matter in detail and are pleased to accord Administrative Sanction for the Scheme 'Financial Assistance to Children with Special Needs (CWSN) in Std. I to VIII under Student Centric Activities 2016-17' subject to the following specific conditions in addition to the general conditions.
 - a) Expenditure has to be limited to budget allocation of ₹7,40,00,000/- (Rupees Seven crore and Forty lakh only) by excluding the hike in Books and stationery allowance and assistance for the year 2016-17 and arrear amount for the year 2015-16.
 - b) The expenditure in this regard should be met from the Head of Account 2202-02-109-70(P) for Student Centric Activities 2016-17.

c) The DPI should ensure that the funds released has to be disbursed to the beneficiaries (Students) through the Bank accounts opened for the purpose and report compliance to Government.
