CIRCULAR

Sub:—Defects / Deficiencies noticed in the inputs on Provident Fund matters received in the Office of the Principal Accountant General (A&E) from various Controlling Officers/Heads of the Departments/Drawing and Disbursing Officers/ Treasuries—Instructions—Issued.

Ref:—Letter No. FM II/9-451/2014-15/601 dated 15-10-2014 and Lr. No. FM II/9-451/2014-15/844 dated 15-1-2015 from the office of the Accountant General (A&E), Kerala, Thiruvananthapuram.

The Accountant General (A&E) in his letters cited has brought to the notice of Government the following defects deficiencies in the inputs on Provident Fund matters received from various offices.

1. The application form for admission to GPF has a provision at Sl. No. 10 to note the Permanent Employee Number (PEN) of the applicant. In certain cases application for admission to GPF is forwarding without PEN. While forwarding the application for admission to GPF, the PEN should invariably be noted at Sl. No. 10 of Form 'A' for the smooth transfer of electronic data. Applications received without noting the same will be objected.
